### A. General information

- 1. What are the climate change current strategies/policies in place?
- 2. How was your organisation involved to the development of these policies/strategies?
- **3.** What are the actions currently being undertaken as part of climate change adaptation/mitigation in your city/region
- **4.** In your opinion, what actions need to be undertaken for a successful climate change adaptation/mitigation practice at local authorities?
- **5.** Do you believe that the current planning framework and design standards are adequate for climate change adaptation/mitigation? Why or why not?
- **6.** Does/Did the city/authority rely on external expertise in order <u>to develop</u> climate change adaptation/mitigation planning documents or have significant parts of development been sub-contracted?
- **7.** Does/Did the city/authority rely on in-house expertise in order <u>to develop</u> climate change adaptation/mitigation policies?
- **8.** Does/Did the city/authority rely on external expertise in order <u>to implement</u> the <u>climate</u> change adaptation/mitigation planning <u>measures</u> or have significant parts of development been sub-contracted?
- **9.** Does/Did the city/authority rely on in-house expertise in order <u>to implement</u> the climate change adaptation/mitigation measures?





- **10.** What are the external supports available for climate change adaptation/mitigation measure implementation?
- **11.** In your opinion, what were the main barriers the city/authority faced while developing climate change adaptation/mitigation policies/planning documents?
- **12.** In your opinion, how important are the following factors in implementation of **climate change adaptation/mitigation policies** for your city?
- **13.** In your opinion, which are the main obstacles for the implementation of **climate change adaptation/mitigation policies** for your city/region?

- 1. How do you perceive the importance of cooperation between the different relevant stakeholders (e.g., public administration, business, civil society) in terms of climate change adaptation/mitigation in your city?

- **3.** Does your city have a special department in charge of stakeholder (incl. citizen) engagement?
- 4. If not, in which form does your city organise its stakeholder engagement activities?
- **5.** How would you describe the level of integration of the stakeholder engagement actions in the decision-making process in your city / city region?
- **6.** How is the citizens' participation organised in your city / city region?
- 7. Which are the main barriers you had regarding stakeholder engagement and participation?
